## **USDA Pauses FY26 REAP Program**

The U.S. Department of Agriculture (USDA) issued <u>a notice</u> on June 30, 2025, that the Fiscal Year 2026 (FY26) Rural Energy for America Program (REAP) will not be accepting applications. The FY26 application window was originally expected to open between July 1- September 30, 2025. While grant applications received during this time will not be reviewed by the Agency, guaranteed loan applications will continue to be accepted and reviewed. USDA expects to begin accepting REAP applications again on October 1, 2025.

### Groundswell RFP for Solar Developers to Expand Community Solar Across the Southeast

Groundswell is accepting proposals from experienced solar developers to bring new community solar and battery storage projects to rural communities in Alabama, Arkansas, Florida, Georgia, Mississippi, North Carolina, South Carolina, and Virginia through the Southeast Rural Power, Solar for All Program. This Request for Proposals (RFP) will remain open until August 8, 2025, 5:00 p.m. ET. The full RFP can be found here.

### Wisconsin Public Service Commission Rural Energy Startup Program

The Wisconsin Rural Energy Startup Program (RESP), supported by funding from the U.S. Department of Energy's Energy Efficiency and Conservation Block Grant (EECBG), continues to accept applications beyond the most recent grant round's July 16, 2025, application deadline, until funding is expended. Eligible applicants include local governments that have not received direct allocations from DOE's EECBG program and rural communities. # Idaho Governor's Office of Energy and Mineral Resources Accepting Applications for Government Leading by Example Program

The Idaho Office of Energy and Mineral Resources (OEMR) is accepting applications from rural cities and counties that want to save energy in existing public buildings. Approved applicants will receive a building energy audit which will identify energy saving opportunities and may qualify for some cost-share funding on energy efficient retrofits. # Ohio House Bill 15 Enacted and Incentivizes Energy Development on Brownfields

Governor DeWine signed Ohio House Bill 15 into law in May 2025, which incentivizes and accelerates energy development, including renewable energy projects, on former industrial sites, landfills, and abandoned mines. The bill text can be found <a href="here">here</a>.

# West Virginia Critical Mineral Recovery on Reclaimed Mine Lands

State government, researchers, nonprofits, and community groups in West Virginia have been leading efforts to restore mountain streams and rivers across the state that have been polluted with acid mine runoff from abandoned mines. A higher-tech version of this cleanup process recovers rare earth minerals that can be used for producing batteries, solar panels, and other clean energy technologies.

Land Use Code Guidance for Deploying Agrivoltaics in Colorado

This new resource from the Colorado Agrivoltaic Learning Center helps Colorado's county-level planners and policymakers learn about the benefits and develop regulations to enable agrivoltaic systems, focusing on upfront planning, adaptive designs, and best construction practices. The resource offers guidance on siting, permitting, and regulating agrivoltaic systems in line with local governments' existing land use codes. The full resource can be found here.

## Alaska Energy Authority Role in Supporting Rural Energy Infrastructure

This video captures the Alaska Energy Authority's (AEA) role in maintaining critical energy infrastructure that service rural areas. To this end, AEA conducts facility condition assessments, offers project funding, and deploys circuit riders for on-site technical assistance and vocational training on operating powerplants and bulk fuel systems.
